TDS Recalculation from a Specific Date in a Financial Year *Product: Finacle Core Banking* | *Version: 10.2.12 and above*

Banks may have a requirement to recalculate the **TDS** for an account at a different rate from what was set at the beginning of the financial year due to changes in the **CBDT** taxation rules. It may also be required that the different rate is applied from a specific start date, leaving the **TDS** deducted earlier to that date in the same financial year as unchanged. To aid this functionality the following activities can be undertaken at the **CIF** level:

- Change the **TDS** table code to the desired rate related table code
- Update the **No Tax Recalculation Beyond Date** so that any **TDS** already deducted at earlier rate prior to that date remains unchanged. This will ensure that the **TDS** is not recalculated before this date. So, any changed **TDS** rate will be applicable from this date.

The backend field mapping for these fields are:

- TDS table code to be setup in CRMUSER.ACCOUNTS.Tds_tbl
- The recalculation cut-off date should be setup in the CRMUSER.DEMOGRAPHIC.no_tax_recal_beyond_date for retail customers and CRMUSER.PREFERENCES.no_tax_recal_beyond_date for corporate customers

Impact with respect to the India localization features

In case the **MTDSE** menu was used for capturing **TDS** exemption, then to enable the above feature the record captured in **MTDSE** should be deleted. The corresponding table is **IN_TECT**. The **Del_Flg** in this table can be updated to **Y**. At account level the withholding tax flag for the eligible accounts of the customer is to be set to **T** (**GAM.wtax_flg**). If the exemption is to be revoked then additionally in the **IN_TDS** table for all eligible records that need to be considered for the new taxation rate, the **EXMP_SRL_NUM** should be made as **NULL**.

Security Questions and Answers for Authentication *Product: Finacle Online Banking/ DEH* | *Version: 11.2.x till 11.13*

Security Question and Answers (**SQNA**) is a security feature in Finacle Online Banking/ DEH that allows the bank to set a few predefined security questions and collect answers from users to be used for user authentication.

Configuring the Security Questions by the Bank Admin

The bank can define the random questions that will be used to setup the **SQNA**. These questions will be inserted in the **LAFQ** table. There is no frontend menu for creating these questions and the bank can insert the questions manually via insert DB scripts to the **LAFQ** table. The **Question_ID** should be unique while inserting the records.

To enforce the security questions to be set whenever the customer logs in for the first time, the below configurations are needed:

• FORCE_QNA_CHANGE_FLG should be set to Y in the CUSR table (for 11.2.X) or UCDT table (for 11.5 till 11.13). This will display the security questions to the end user for registering. Once security questions are registered successfully, this flag will be updated to N

SECONDARY_AUTHENTICATION_MODE needs to be SQNA in the CSIP table. This ensures that security
questions will be displayed to the user as a secondary authentication mode in subsequent logins

Setting Security Questions and Answers by User

When the security question mode is enabled and the user tries to login for the first time, the application will forcefully display a page by randomly picking the questions from the **LAFQ** table. The number of questions to be displayed and set are decided based on the below **PRPM** properties:

- **MIN_QUESTION_COUNT** Minimum number of questions the user needs to answer
- **MAX_QUESTION_COUNT** Maximum number of questions the user can answer

For example: If **MIN_QUESTION_COUNT** is 2, **MAX_QUESTION_COUNT** is 3 and there are 5 questions in the **LAFQ** table, then 5 dropdowns will be displayed to the end user with 5 questions each. The end user can choose from the dropdowns and answer a minimum of 2 questions and a maximum of 3 questions. Once the chosen questions are answered by the user, the data will be inserted into the **LAFA** table in encrypted format.

At the time of authentication, all the questions answered by the user at the time of security question registration will be displayed for authentication.

In the Internet Banking application, the end user can also update the security questions using the below menu:

Login \rightarrow Security Settings \rightarrow Security Questions

Retrieval of questions and updating of the answers will be in the same way as mentioned above. Once the details are submitted, records will be updated in the **LAFA** table.

TDM 30/ 360 Deposit

How to open a TDM-30/360 type of deposit in Finacle? What setup is required and how the interest is calculated in TDM method. Few banks have requirement to open a TDM method of deposit accounts.
